

Tariffs for customers for transfer of money via PS BLIZKO

- 1. Tariff plan «Standard».** Set for trans-border and transit money transfer via service «Transfers in a favor and upon request of individuals to/from any countries operating with PS BLIZKO, except for money transfer to/from the following countries: the Republic of Austria, Hungary, the Hellenic Republic, the Italian Republic, the Kingdom of Denmark, the Kingdom of Sweden, Mongolia, Transnistria, the Republic of Belarus, the Republic of Moldova, the Republic of Poland, the Republic of Uzbekistan, the Slovak Republic, the Federative Democratic Republic of Nepal, the Federal Republic of Germany, the French Republic, the Czech Republic.

- 2. Tariff plan «Standard PLUS».** Set for trans-border and transit money transfer via service «Transfers upon request of individuals to/from countries: the Republic of Austria, Hungary, the Italian Republic, the Kingdom of Denmark, the Kingdom of Sweden, Mongolia, Transnistria, the Republic of Moldova, the Republic of Poland, the Republic of Uzbekistan, the Slovak Republic, the Federative Democratic Republic of Nepal, the Federal Republic of Germany, the French Republic, the Czech Republic, except for money transfer to/from the Hellenic Republic, the Republic of Belarus.

- 3. Tariff plan «Maximum».** Set for trans-border and transit transfers of money via service «Transfers in a favor or upon request of individuals» to/from Republic of Belarus.

4. **Tariff plan «Forsage»²**. Set for trans-border transfers of money via service «Forsage».

| from 8 277,78 to 150 000,00 | 1,8% of transfer amount |
